PS 1: Assessment and management of Environmental and Social Risks and Impacts				
1.1	E&S Assessment and Management System	Continue implementing, in all its units, an integrated E&S, Health and Safety Management System consistent with the requirements of PS 1 related to health and safety issues for both industrial and agricultural areas covering the following actions: (i) improving the policy to internalize all IFC PS 1 guidelines, establishing annual improvement goals as part of the business planning and sharing the policy and procedures with the suppliers; (ii) defining the procedure, schedule and technical team needed to carry out, review and improve risk assessments, and implementing a procedure with the involvement of its personnel in the risk assessment; (iii) developing an EHS and operational changes improvement action plan establishing performance standards for management programs; (iv) assessing personnel training and identifying the system improvements and weaknesses in order to optimize emergency preparedness and response measures, and having the Top Management review the procedures; (v) establishing procedures to monitor and measure the effectiveness of the management program and the compliance with any legal and/or contractual obligations and regulatory requirements.
